Accessing the Portal

Within three (3) to five (5) business days of completing the training, you will receive an email from the Systems Mapping and Training Center at Policy Research (<u>smtc@prainc.com</u>), notifying you that a trainer account has been created for you.

Welcome Email

You will receive a welcome email that looks similar to the below email with the subject line "Hi [Your First Name], here is the login information for SMTC." - 3. Scroll down to the "Trainer Materials" section and click the "Slides with Video" link. There are multiple options to choose from.
 - The preferred option is Slides with Video (YouTube link embed; PPT Show file). This file is most useful when you are presenting in a venue that will have an active internet connection.
 - The second option is Slides with Video (Videos directly embedded; Zipped PPT Show file). This file has the videos directly embedded into the PPT file. It is much larger than the YouTube link file and will take some time to download.
