## Q&A with Danny Howe, Serial Entrepreneur; Founder, The Earnest House and The HOWE Project

Danny Howe is the founder of multiple small businesses in Tucson, Arizona, all of which provide opportunities to individuals reentering the community from incarceration. His passion for helping others stems from his lived experience with the criminal justice system.

# Since 2016, The Earnest House has provided a safe environment to help individuals transition from incarceration to the community. What inspired you to establish this housing program?

I was on probation when I was 9 years old. By age 18, I had been expelled from school and faced 68 years in prison. I served time through a plea deal, but within a few years, I was back in trouble for guns and drugs. With no job, apartment, or driver's license, I just kept returning to the same old things and ending up in the same situation. My life changed when a local company believed in me enough to offer me a job. This was a tremendous confidence builder, which ultimately led me to earn an associate degree and a career at the Pima County One-Stop Career Center.

### Opioid Intervention Courts: Preventing Overdose and Improving Legal Outcomes

When people with opioid use disorder (OUD) participate in drug court, research shows that they are far less likely to graduate than people with other substance use disorders, making them more vulnerable to lethal overdoses. In 2017, a week of multiple fatal opioid overdoses by individuals awaiting second appearances in traditional drug court prompted the establishment of the first Opioid Intervention Court (OIC) in Buffalo, New York. This judicially supervised triage program offers immediate screening and life-saving intervention (including medications for OUD [MOUD]), without waiting until cases are adjudicated or otherwise resolved in court.
