

### Elan Hope Co-leads New Research Grant Studying Mental Health Benefits of Racial Justice Activism in Youth

The Ann & Robert H. Lurie Children's Hospital of Chicago and Policy Research Associates have been awarded a 5-year research grant from the National Institute on Minority Health and Health Disparities. This project will be led by Vice President Elan Hope, PhD, and Nia Heard-Garris, MD, of Lurie Children's Hospital of Chicago. Their project, "Our Voices Matter: Racial Justice Activism Intervention to Address Structural Racism and Prevent Depression in Black and Latinx Youth," will study the potential behavioral and physical health benefits of racial justice activism in teenage youth.



"This is an exciting project and one of the first of its kind to test activism as an intervention to reduce symptoms of depression and physiological measures of stress for adolescents. Structural racism is known to cause stress and deterioration of health over time. We know early intervention with teens is key for reducing the long-term impacts of that chronic stress on mental and physical health." —Dr. Hope

To learn more about this award, the study, and the next steps, read the Lurie Children's Hospital of Chicago press release:

"Three hundred Black and Latinx teens in Chicago will be recruited to participate in the first clinical trial to measure the potential health benefits of youth-driven racial justice activism. The five-year study, funded by a \$3.8 million grant from the National Institute on Minority Health and Health Disparities, will assess whether activism can lower depression symptoms in minoritized teens, as well as alter physiological factors known to be increased with exposure to racism, such as blood pressure and markers of stress and inflammation in the blood."

The Homeless and Housing Resource Center has launched an online course, "Introduction to Hoarding Disorder." This course teaches registrants about hoarding among people experiencing homelessness and housing instability. Enrollees will:

- review hoarding, homelessness, and housing instability;
- come to understand why hoarding is a significant concern when working with people experiencing homelessness and housing instability; and
- learn strategies to work with people experiencing this situation.
